

RADM Cozad Speaks at Admirals' Club Event



The Pensacola Navy League Admirals' Club held the first in-person event in 2021. The Meet the Boss speaker series luncheon was held April 6th at Pensacola Yacht Club. The event was emceed by VADM Jerry Unruh, USN (Ret) and the guest speaker was RADM Kyle Cozad, USN (Ret). RADM Cozad is the President and CEO of the National Naval Aviation Museum Foundation.

As a flag officer, Cozad's assignments, in part, included Vice Deputy Director, Regional, Force Management and Future Operations (J-35), The Joint Staff in Norfolk, Virginia; Commander, Joint Task Force Guantanamo; and Commander, Patrol and Reconnaissance Group and Patrol and Reconnaissance Group Pacific in Norfolk, VA. Cozad became the 19th Commander of the Naval Education and Training Command in July 20, 2017. He holds numerous awards and in February 2019, he attended a Navy-sponsored adaptive sports camp. He subsequently tried out for and was selected to the 40-member team representing the Navy in the 2019 Warrior Games. He retired from the Navy in 2020.

RADM Cozad discussed the challenges the museum has endured under heightened security and a pandemic. Since the 2019 terrorist attack at NAS Pensacola, access to the base has been limited to holders of DoD ID cards and their guests. For seven months in 2020, the museum was also closed due to the COVID-19 pandemic. The National Naval Aviation Museum is a major draw of tourism to the area.

During his military career, Cozad served as the twenty-second Senior Director of the White House Situation Room and as a Chief of Naval Operations (CNO) fellow on the CNO's Strategic Studies Group.

"I had an opportunity to work in D.C. at the White House for two years, and if you wanted to visit the White House, you put in a reservation request," said Cozad. "It vetted you through a security system to make sure you didn't have any outstanding warrants. I thought, if it was good enough for the White House, why can't we apply a similar mechanism here?"

RADM Cozad told the Admirals' Club guests that museum staff are hoping to create a reservation system in which members of the public can undergo a security screening to get access to the museum and other historic attractions on the base. The system would require visitors to do a pre-security screening. Once cleared, they can enter the base for an appointed amount of time on a specific day.

"I'm confident that, if we can get approval for the system, then we can rise from 50,000 visitors last year, back up to 500,000 or more visitors in the next two years." Cozad said.

The next "Meet the Boss" luncheon will be held June 8th.

A special **Thank You** here goes out to Dave Richards of **Blue Coral Fiberglass**, for his phenomenal repair work. Once the body work was completed, PNL approached the World Famous Blue Angels for their assistance with a new paint job. Coordination with Blue Angel XO, CDR Todd Royles, USN, MO LT Brian Abe, USN and the incredible Blue Angels Corrosion Control Team, resulted in a paint job that is second to none! “Blue 1” now sits, “spit-shined and inspection ready,” patiently awaiting his new perch to be built. The new perch will be erected at his old familiar “watch station” on the western corner of Garden and Palafox Streets downtown. The new perch will look like those of his military Pelican comrades on the north side of the intersection. After the new perch has been completed, an appropriate reinstallation Ceremony for “Blue 1” will be conducted. Details of the reinstallation Ceremony will be forthcoming. Stay tuned.....

CHAPTER TWO; THE MARINE CORPS PELICAN

With the Navy Pelican standing watch and gaining much attention in 2004, it did not take the Marine Corps long to develop, dare I say it, Pelican envy. By 2005, the Marines decided to post a Pelican of their own. And as you know, when the Marines decide to do a thing, it gets done. In this case MATSG-21, under the command of Col Chris “Caveman” Holzworth, USMC and his XO Lt Col Dave “Gman” Glassman, USMC, decided that a Marine Corps Pelican was in the Corps’ best interest. Direction was given and orders were issued. A USMC Pelican was to be “on watch” post haste. First challenge, find a Sponsor. These Pelicans, remember, are not cheap. Happily their fundraising efforts were a success. Mr. Ted Ciano, known as Mr. “C” to everybody in Pensacola stepped up.

Mr. "C" owned Ted Ciano's Ford car dealership. No greater patriot or supporter of the military than Mr. "C" existed. He was all in. The checkbook opened, problem solved. A Pelican was purchased. Then an artist was found in Kenner, LA., to prep the bird and lay on the beautiful Marine Corps paint job. The only way to describe the quality of the USMC insignia, which are emblazoned on the front and back of the Marine Corps Pelican, is to see it.

Once the Marine Corps Pelican, now being referred to as "Leatherneck" by some and "Devil Dog" by others, was painted and ready, an installation Ceremony was in order. And if the United States Marine Corps knows how to do anything, it knows how to put on a show. So this installation Ceremony was going to be a whopper, and a two-parter no less. The first part; storm the beach at the Pavilion on Pensacola Beach. Now when I say storm the beach, I am not kidding. MATSG-21 incorporated a beach landing exercise into their Ceremony that included amphibious vehicles and camouflaged Marines. Dignitaries for the event included; Mayor John Fogg, a former Marine and Blue Angel offering Keys to the City, General William "Spider" Nyland, USMC (Ret), representing the highest levels of Marine Corps Leadership, along with local government and civic leaders, Col Holzworth and his staff, Mr. "C" himself and of course, a boatload of Marines in formation. All of this rocking to the tunes of

Cat Country with a crowd sitting in bleachers set up for the occasion. Wow. What an event!

Once established on "watch," "Leatherneck" found himself in much the same circumstances as "Blue 1." Many admirers, a few curiosity seekers, the occasional hater. "Leatherneck," well-trained, stoically endured it all. He performed his duties as befitted any good Marine. He weathered the storms, enjoyed the Parades, endured the occasional overzealous tourist and stood his ground with distinction. Life in general was good for him, right up until the night a particularly angry non-fan decided to go after "Leatherneck" with a vengeance. How the altercation got started is unclear. What is clear is that when the dust settled "Leatherneck" had multiple lacerations and a severely broken wing. How the other guy looked is unknown but I suspect that "Leatherneck" gave as good as he got. Then while convalescing, like any good Marine, "Leatherneck" learned some lessons from his skirmish. He now has steel reinforced wings and the once hollow body is filled with foam. While outside the wire these days, "Leatherneck" has his own body armor. That said, even body armor cannot stop the effects of weather and graffiti. So after standing "watch" for the last couple of years, it was time for a little TLC. The decision was made to upgrade "Leatherneck's" perch. So while currently awaiting construction of a new elevated perch that will match his fellow Pelican sentinels to the north, "Leatherneck" is in the shop for a spruce up. His makeover and new perch should be completed in time for "Leatherneck" to be the center of attention during the Gold Star Family recognition event and Memorial Day Parade. Following his re-installation and when the opportunity presents I strongly suggest that you drop by and have your photo taken with our very own Pensacola Marine Corps legacy.



MEET THE BOSS

Join us for the next Admirals' Club Meet the Boss speaker series luncheon on Tuesday, June 8th, at 11:30 am at Pensacola Yacht Club. Guest speaker is **Chip W. Simmons**, Former Chief Deputy with the Escambia County Sheriff's Office. Simmons was elected Sheriff in 2021. The Escambia County Sheriff's Office currently employs 650 people, serving nearly 300,000 citizens in the county.

Chip Simmons previously served as Assistant County Administrator for Escambia County and as Police Chief for the Pensacola Police Department before retiring from the Police Department in August 2015. He began his law enforcement career in 1984 as a corrections officer for the Escambia County Sheriff's Office and was hired by the Pensacola Police Department as an officer in 1986. His assignments have included uniform patrol, investigations, narcotics and SWAT.



Chip was born at Naval Air Station, Keflavik, Iceland. He attended Bellview Elementary School and Bellview Middle School and graduated from Pine Forest High in Pensacola. He holds an associate's degree in criminal justice from Pensacola Junior College, a bachelor's degree in criminal justice from Troy State University, a master's degree in public administration from Troy State University, and graduated from the FBI National Academy in Quantico, VA.

He held memberships on the Statewide Terrorist Network Group, Organized Crime Drug Enforcement Task Force, U.S. Customs Blue Lightning Strike Force, Favor House board of directors, Ronald McDonald House board of directors, and on the board of Trustees for Pensacola State College. He is a member of the Leadership Council for Achieve Escambia, a member of the Lakeview Board and Manna Food Bank. He was a member of Leadership Pensacola class of 2004.

Chip has received numerous department awards in recognition of his service to the community including a Bronze Cross and the Gold Medal of Valor, which is the department's highest award for heroism. He also has been named to the Police and Firefighters Heroes Hall of Fame, the Pine Forest High School Alumni Hall of Fame, and received the Volunteer of the Year and Sports Lifetime Achievement awards from the Emerald Coast Youth Sports Association. In 2013, he received the Mayor's Leadership Award for the city of Pensacola.

Pace High School Navy JROTC Drill Team Wins National Championship

Pace High School's Navy JROTC program beat out more than 600 schools to earn a national drill championship this year.

The program was awarded first place overall in the Navy Nationals Academic, Athletic and Drill Competition, which members of the team describe as the "Super Bowl" of Navy JROTC. The drill team was honored at an award ceremony at Pace High on Thursday afternoon.

"I think it was just a surreal moment whenever we got announced. We've been working so hard for it and just being announced as actually being the No. 1 (drill team) in the nation, it's just such an accomplishment you can't wrap your brain around just in that exact moment. It takes a couple minutes to be like 'Oh wow. We really just won that thing,'" said Caitlin Proper, a junior at Pace High and this year's public affairs officer.

Navy JROTC is an elective offered for students at Pace High School, which has an enrollment of about 160 students. The program is meant to teach citizenship and leadership development. Fifty of those students participate in the extracurricular drill team, which has practiced every weekday morning from 7:30 to 8:45 a.m. since September.

In a normal year, the drill team would compete in four or five meets in a season, however, because of COVID-19 restrictions, they were only able to attend one local competition. The competition includes five different drill categories, as well as three athletic events such as push ups, a 100-yard relay and academic tests and inspections.

Each spring, the country's top 24 teams are chosen to compete in a national championship. This year it was held virtually, so Pace's drill team had to video record their drills and athletic events and send off academic tests to be graded.

"Our drill practices and preparing for this competition almost was our rally cry to have some fun together and work toward a common goal. It became, for a lot of students, their 'why' in a difficult year, (which) was ROTC and being on the drill team and working toward trying to win this championship. So in a lot of ways, it helped get us through the year also," said 1st Sgt. John Baker, Pace's naval science instructor.

The national champions were announced virtually this year, instead of at the usual location aboard Naval Air Station Pensacola, so the drill team members, as well as school administration, watched it to-

gether in a classroom at Pace High. Baker said with every category that was announced, Pace ended up in the top five, which gave them a good shot at landing the overall championship.

"(I was) just thinking as we get through those, 'Hey, I think we may win this.' And so at No. 2 and No. 1, I had my phone out ready to start recording the kids. And when they announced the first place overall, we were in the classroom. Our principal administrators were in there with us. And it was euphoria," Baker said, adding that his video has received thousands of views online.

The individual category results were:

- 5th in pushups
- 4th in curl ups
- 2nd in 100-yard relay
- 3rd in unarmed basic drill
- 1st in armed basic drill
- 5th in unarmed exhibition drill
- 2nd in armed exhibition drill
- 5th in color guard drill
- 1st in academics

The student leader of Pace's JROTC is Cadet Commanding Officer Justin Liaw. He found his way to JROTC after simply noticing it was a free program on a brochure. Now, Liaw is Pace's valedictorian and has been accepted into the U.S. Naval Academy.

"There's like a week before school where they kind of teach us what ROTC is about and how it's all ran, but the senior leaders there and seeing students running everything was the most amazing thing to me, and that was when I decided I wanted to be one of those leaders as well," Liaw said.

Liaw said this year's team was less experienced than in years past and had plenty of freshmen. He knew that meant the team had to work hard to live up to the school's reputation. While neither Proper or Liaw are from military-connected families, Liaw said the schools around Escambia and Santa Rosa counties have strong military cultures, which makes the JROTC programs even more competitive.

The schools in the area are highly competitive and we compete against each other pretty heavily," Liaw said. "We really work to beat each other and that ends up making us all better, so

WELCOME HOME USCGC DILIGENCE

The USCG Cutter DILIGENCE and her crew returned to their homeport at NAS Pensacola on April 29th, returning from a fifty-nine day deployment in the Caribbean. The Diligence crew performed search and rescue, counter-drug and alien migrant interdiction operations in support of the Coast Guard 7th District. During the patrol, the crew received 14 migrants apprehended by other U.S. law enforcement agencies and orchestrated their successful transfer to Cuban and Bahamian immigration officials. The crew also facilitated the transfer of three suspected drug smugglers apprehended by another Coast Guard cutter, to U.S. law enforcement authorities in Puerto Rico. The cutter's primary missions are counter-drug operations, migrant interdiction, enforcing federal fishery laws and search and

rescue in support of Coast Guard operations throughout the Western Hemisphere.

JOIN THE PENACOLA NAVY LEAGUE

We welcome everyone to join our Pensacola Navy League and participate in our Council Events. Many of our activities offer both member and non-member prices. The non-member price option is for those not yet ready to join, but interested to see what the Navy League is all about. Additionally, Membership in the Pensacola Navy League offers perks to our members as a function of their level of membership. Examples of such perks include; invitations to free events, discounted tickets to special events, recognition, and more. In order to join and participate in the local Pensacola Navy League, membership with the National Navy League is a prerequisite. The categories of membership in the Pensacola Navy League are:

Regular Member – Any citizen of the United States desiring to support and advance the objective and purpose of the Navy League shall be eligible as a Regular Member. Active Duty members of any branch of the armed service persons are not eligible for membership while on active duty. Reservists are eligible for membership, but while on active duty are not eligible to vote or hold a Navy League office.

Honorary Member – Any outstanding person who has shown and expressed unusual interest in this Council and who has made significant accomplishments at local, regional, or national level of the Navy League shall be eligible for Honorary Membership upon unanimous approval of Council Members present at a regular monthly meeting. No dues shall be assessed against such Honorary Members. Honorary Members are privileged to take part in all social activities of the Council but shall not be eligible to vote or hold regular office in the Council.

Associate Member – Non- citizens may be Associate Members provided that they are proposed by a Council and not by an individual. An Associate Member shall be entitled to vote and hold office at the Council level, with the exception of serving as Council President. Current annual dues structure applies.

Guest Member – National Members who are not dues paying Local Members shall be designated as Guest Members. These members will receive invitations to local events but charged a higher cost than Regular Members. Guest Members shall also be eligible to receive the Bullhorn Newsletter via e-mail.

Spouse of Active Duty Personnel – Active Duty Spouses are eligible for either a FREE E-membership or a regular membership at a reduced rate; however, they may neither vote nor hold office. The offer of a free E-membership has been extended from 2020 until the end of 2021.

Community Affiliate Membership – Community Affiliate Membership is designed for companies whose business is primarily local rather than national in orientation, whose primary interest is in the activities and concerns of the local Council and desire to support and advance the mission and objectives of the Navy League. During each year of membership, a Community Affiliate Member may designate up to four (4) Regular Members, provided such Members are otherwise qualified. Designated members enjoy all the privileges of individual Membership including the right to vote and hold office.

Members in Good Standing - Members whose dues are current shall be considered Members in Good Standing, and shall have all resulting rights and privileges of membership including the right to vote and to serve as Council Officers and /or on the Council Board of Directors.

General - Each applicant for membership shall be presented to the Board of Directors for approval. Upon approval, the Executive Secretary will provide the National Headquarters with appropriate documentation and national dues, if appropriate


